North South Yachting, in conjunction with Royal Prince Alfred Yacht Club, extends an invitation to owners of Bavaria Yachts, Bavaria Match Yachts and North South Yachting performance brand yachts to enter the 2010 North South Yachting Pittwater Regatta.

1. Rules

The 2010 North South Yachting Pittwater Regatta shall be governed by the 'rules' as defined in the 2009-2012 Racing Rules of Sailing (RRS), the Special Regulations of Yachting Australia (YA), except as any of these are altered by this Notice of Race or the Sailing Instructions. All boats are to race with a headsail and mainsail only; spinnakers shall not be permitted.

Specific attention is drawn to RRS Fundamental Rule 4, which states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

2. Alteration of Racing Rules

All yachts are required to remove their anchors from the bow and anchor roller while racing.

3. Eligibility and Entry

The 2010 North South Yachting Pittwater Regatta is open to all Bavaria & North South Yachting performance brand yachts.

- Each yacht is required to lodge with North South Yachting, a copy of a current YA Special Regulations Equipment Compliance Form Category 7.
- Yachts are required to hold Third Party Liability insurance of at least \$10,000,000 in the name of the boat.

North South Yachting reserves the right to allocate boats to divisions and to combine divisions.

North South Yachting must receive the above documentation and the signed declaration attached to this Notice of Race **BEFORE 4:00pm Tuesday 6th April 2009.**

4. Fees

An entry fee of \$90.00 shall accompany an entry for the regatta.

5. Schedule of Events

1300	Lunch in Pittwater on your boat
1430	Race 2
1700	Presentation followed by BBQ at the RPAYC

6. Sailing Instructions

The Sailing Instructions shall be available from Royal Prince Alfred Yacht Club on Sunday 11th April 2010 at registration. The race briefing shall be held at 0945 at the Royal Prince Alfred Yacht Club.

7. Racing Area

The 2010 North South Yachting Pittwater Regatta shall be held on the waters of Pittwater.

8. Courses

The courses shall be around fixed marks as further detailed in the Sailing Instructions.

Scoring

The RRS Appendix A, Low Points scoring system shall be used. There shall be no discard race.

9. Handicaps

The 2010 North South Yachting Pittwater Regatta shall use Performance Handicaps set by North South Yachting. These shall be based on the boat and equipment; allowances may be made for folding propellers and additional or non-standard sails when determining a yachts handicap. A yachts handicap shall not be grounds for requests for redress.
